- Airport to Airport (Mandatory) - USD\$270.00
- Plus Quarantine (Optional) - USD\$105.00 per month
- Plus Inland Transit to Airport in Country of Origin (Optional) - USD\$50.00
- Plus Inland Transit from Airport in Country of Destination (Optional) - USD\$110.00

SUMMARY OF COVERAGE

Insured against all risks of mortality including the risks of theft and/or non-delivery.
Deductible is USD\$100 per animal.

Insurance does not cover the following:

- (a) pre-existing condition and death caused by an infectious disease;
- (b) pets in parturient condition;
- (c) dogs older than 12 years up to 20 kg;
- (d) dogs older than 10 years between 20 and 40 kg;
- (e) dogs older than 9 years over 40 kg
(Weights to be as of time of health certification.)
- (f) cats older than 15 years.

The maximum period of coverage shall be seven (7) days, defined as 168 continuous hours after attachment of this insurance, including pre-export Inland transit in the country of origin, until safe discharge from the aircraft at airport of destination, unless any of the above optional extensions are shown as being elected:

- Quarantine Coverage - As above, but including the minimum period of quarantine legally mandated by the country of destination. In no event shall quarantine period exceed 180 days for shipments to Japan, Hong Kong, Australia and/or the United Kingdom, or more than 60 days for all other destinations.

- Post-import Transit in country of destination: as above, but including up to an additional three (3) days, but in no event beyond the moment shipment is safely received at final destination.

Animal to be valued at cost of replacement by weaned puppy or kitten of the same breed at destination, including the costs of transportation, transportation documentation, health compliance and documentation thereof, quarantine, if required and customs entry. However, in the event an animal is not replaced, valuation shall be the total of the incurred costs and charges for which the owner is responsible up until the time of loss. In no event, however shall the insurance company be liable for an amount in excess of the USD\$15,000.00.

Special Note: At any point during the period of coverage if the pet becomes injured, appears ill or is in distress, it is your obligation and responsibility to immediately obtain care and attention by a professional veterinarian duly licensed by the local authorities. **Failure to do so may void a claim!** Report claimsto iti@intertransins.com.
